Job description/ Eligibility criteria:

- 1. Holding the analogous post of Sr. Accountant/Sr. Auditor/ Accountant/Auditor as mentioned above
- 2. Possessing in knowledge and experience in operating computer for office related work.
- 3. Possessing of work experience with regard to Accounting & Administrative work relating to IA &AD.
- 4. Those who have already worked in RTIs/RTCs will be given preference.

Terms of deputation & selection process:

- 1. All officials who are willing should apply for the deputation through their respective Parent Offices. The Parent Offices are requested to forward such applications along with the Bio-data and APARs for the last five years duly attested on each page to this Institute, so as to reach this Institute latest by **21-02-2022**. It may also be certified that no disciplinary/court/vigilance case is either pending or contemplated against the applicant. The required documents of the eligible candidates to be forwarded by the respective Parent offices may be scanned and sent by email to avoid postal delay.
- 2 The term of deputation will be for a period of three years initially and extendable on yearly basis thereafter. This institute however, reserves the right to repatriate a deputationist at any time, if his/her performance is found unsatisfactory.
- 3. The selected official will be entitled to Deputation Allowance as per instructions prevailing from time to time.
- 4. Selection of a suitable official shall be made through the appropriate selection procedure for knowledge and skill based jobs and the selection of the applicant shall be notified.

- 5. Maximum age limit for appointment by deputation should not exceed 56 years as on the closing date of application for the post. *However, relaxation in age will be considered, on the merit of each case.*
- 6. A reference is invited to Headquarters Circular *No.* 269/Trg.Div./42-A/2019 dated 18.09.2019 wherein detailed instructions to field offices on augmentation of staff (Administration and Faculty) in RTIs/RTCs were issued for strict compliance. The instructions in the said circular are re-iterated below:
- **a.** Field offices shall display the deputation notifications issued by RTIs/ RTCs on the notice boards and circulate among the staff giving reasonable time to the candidates for responding to the notification;
- **b.** Field offices shall forward all applications received from their officers/staff against the positions advertised by RTIs/RTCs to the concerned Institute/Centre, without withholding any application;
- **c.** On completion of the selection process, the field offices shall obligatorily relieve the selected officer(s) for teaching/administrative assignments at RTIs/RTCs at the earliest.
