pension/family pension of the retired Judicial Officers of
Government of Madhya Pradesh.*

In continuation to this office circular No. Pen. Co-ordn./M P/Vol.-VII/DR-Judi/118 dated 08-12-2021, this is to state that the Government of Madhya Pradesh in their Order No. 4124/21-B(1)/2021 dated 08-11-2021 has sanctioned dearness relief on basic pension/family pension including additional pension/family pension at par with the Central Government for their retired Judicial Officers at the rate and from the date mentioned below :

01-07-2021	196% of basic pension/family pension

2. Having been authorized by the Principal Accountant General (A&E) - II, Madhya Pradesh in their letter No. Pension/2177 dated 25-11-2021, it is requested to make necessary arrangement for payment of dearness relief @ 196% on basic pension/family pension of the retired Judicial Officers of Government of Madhya Pradesh with effect from 01-07-2021 after proper adjustment.
