from 01-07-2019, 01-07-2021 and 01-07-2021.

In continuation to this office circular No. Pen. Co-ordn./U P/Vol.-VII/DR/44 dated 20-06-2019, this is to state that the Government of Uttar Pradesh in their OM Nos. 29/2019-G-3-789/X-2019-301/2000T.C. dated 23-10-2019, 6/2021/22099/1401/2020-Finance Section-22-Finance Department dated 24-08-2021 and 24/2021-G-3-804/X-2021-301/2000T.C. dated 22-12-2021 has sanctioned dearness relief to their pensioners/family pensioners on their revised pension/family pension at the rate and from the date as under:

Date of effect	Rate of dearness relief per month
01-07-2019	17% of basic pension/family pension
01-07-2021	28% of basic pension/family pension
01-07-2021	31% of basic pension/family pension

2. In the calculation of dearness relief, fraction of a rupee less than its half shall be ignored while half or more shall be counted as one rupee.

3. These orders will also be applicable to pensioners of Institutions aided from State Fund, under the Education/Technical Education departments, whose pension/family pension is at par with that of the pensioners of the Government of Uttar Pradesh.

4. These orders will not be applicable to the Judges of High Court of Uttar Pradesh, employees of local bodies and public undertakings/corporations etc. in respect of whom separate orders will be issued by respective departments.

5. Having been authorised by the Accountant General (A&E)-II, Uttar Pradesh in their circular letter Nos. Pension Miscellaneous/SSADR-161/1610 dated 21-01-2020, Pension Miscellaneous/LID-64430/1950 dated 12-03-2020, Pension Miscellaneous/628 dated 28-10-2021, Pension Miscellaneous/1027 dated 17-01-2022 and T.S.(C.)/Group-4/S.S./446 dated 24-03-2022, it is requested to make necessary arrangement for payment of dearness relief to all eligible Uttar Pradesh Government pensioners/family pensioners @ 17% with effect from 01-07-2019, 28% with effect from 01-07-2021 and 31% with effect from 01-07-2021 on their revised basic pension/family pension after proper adjustment.
