

OFFICE MEMORANDUM

1. The committee scrutinized the applications submitted by **M/s Fortis Health Care Ltd., Vadapalani, Ch-26** in accordance with the conditions laid down in the Office Memorandum S. No. 11045/36/2012/CGHS/HEC and recommended the aforesaid Health Care Organisation/Exclusive Eye Hospital/Centre for empanelment under CGHS Chennai.

2. Consequent upon the recommendation of the committee, M/s Fortis Health Care Ltd., Vadapalani, Ch-26 empanelled under CGHS Chennai as per the terms and conditions of empanelment and the MOA signed between CGHS and HCO which are enclosed herewith.

3. The revised rates 2014, terms & conditions as mentioned above will come into effect from 13.04.2022. The empanelment shall be for a period of two years from the date of signing of the MOA.
