Subject : **Grant of Dearness Relief to the Retired Judicial Officers / family pensioners of the State of West Bengal - revised rate effective from 01/01/2022**

The Government of West Bengal, Judicial Department under their letter No. I/188529/2022-J/JDN/2A-14/17 dated 19/04/2022 has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been **enhanced from 196% to 203% with effect from 01/01/2022.**

Accordingly, in continuation to this office circular No. Pen. Co-ordn./65 Vol.IV/133 dated 31/12/2021, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ **203%** to the above category of pensioners / family pensioners with effect from 01/01/2022 after proper adjustments of payment already made.

Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Charges for payment are debitable to the Govt. of West Bengal, under head 2071 – Pension and other Retirement Benefits – 01 – Civil – 101 Superannuation and Retirement allowances etc.
