**Show Cause Notice**

On review of the Annual Property Returns submitted by the officials of Divisional Accountants cadre, it has been observed that some officials of Divisional Accountant Cadre ( The list of officials enclosed) have still not submitted the Annual Property Return for the year 2021-22, last date for submission was 31/12/2021, circulated vide this office order No- WM-III/2021-22/10 dated- 21/12/2021.

As provided under Rule 18 GID (31), "If the officers fail to submit the return by 31<sup>st</sup> January, vigilance clearance should be denied to them and they should not be considered for empanelment for senior level posts in Government."

The officials who have not submitted the required Annual Property Return are hereby once again directed to submit their Annual Property Return before 03/06/2022 positively. Along with this, it should also be clarified that why disciplinary action should not be initiated against you for disobeying the above office order.

Non submission of the required return as stated above will be treated as violation of the conduct Rule and will fetch departmental proceeding against the person concerned and may also asked the State Vigilance Unit to verify the details of the property of the erring officials.
