Subject: Grant of dearness relief to the Karnataka Government pensioners/family pensioners with effect from 01-01-2022.

In continuation to this office circular No. Pen. Co-ordn./Karnataka/Vol.-VI/DR/111 dated 30-11-2021, this is to state that the Government of Karnataka in their Order No. FD 22 SRP 2022 dated 05-04-2022 has enhanced the dearness relief from the existing rate of 24.50% to 27.25% with effect from 01-01-2022 on revised basic pension/family pension to their pensioners/family pensioners including the pensioners/family pensioners of the aided educational institutions whose pension/family pension is paid out of the Consolidated Fund of the State of Karnataka.

2. Payment of dearness relief involving fraction of 50 paise and above shall be rounded off to the next rupce and fraction less than 50 paise shall be ignored.

3. This order shall also be applicable to the retired employees who were on

UGC/AICTE/ICAR Scales of pay.

4. This order shall not be applicable to NJPC pensioners. Separate orders will be

issued in respect of those pensioners.

5. Having been authorised by the Principal Accountant General (A&E), Karnataka in their letter No. PM/G III/B 271/2022-23/SS 14525/92 dated 28-04-2022, it is requested to make necessary arrangement for payment of dearness relief to the category of Karnataka Government pensioners mentioned at para 1 & 3 above @ 27.25% with effect from 01-01-2022 after proper adjustment of the amount already paid.
