Subject: Grant of Temporary Increase (dearness relief) to the Gujarat Government pensioners/family pensioners with effect from 01-07-2021.

In continuation to this office circular No. Pen.Co-ordn./Gujarat/Vol.-VI/DR/126 dated 15-12-2021, this is to state that the Government of Gujarat in their FD Resolution No. HGV-102017-O-450-P dated 09-05-2022 has sanctioned Temporary Increase (dearness relief) on revised pension/family pension of their pensioners/family pensioners as under:

Rate of Temporary Increase per month Date of effect 31% of basic pension/family pension 01-07-2021

Temporary Increase at the rates indicated in above table will also be admissible on the additional basic pension/family pension available to older pensioners/family pensioners based on their age.

Payment of Temporary Increase involving a fraction of a rupee shall be rounded off to

the nearest lower or higher rupee.

Other provisions governing grant of Temporary Increase to pensioners such as regulations of dearness relief during employment/re-employment, regulation of Temporary

Increase, where more than one pension is drawn etc. will remain unchanged.

Having been authorised by the Principal Accountant General (A&E), Gujarat in their letter No. Pension/G.R/Special Seal/-GOG-01/31PC/2022-23/OW No. 189 dated 19-05-2022, it is requested to make necessary arrangement for payment of Temporary Increase to all eligible Gujarat Government pensioners/family pensioners on their revised basic pension/family pension @ 31% with effect from 01-07-2021 after proper adjustment.
