The period of deputation will be initially for a period of one year and shall ordinarily not exceed three years subject to his/her continued suitability.

Note 1:The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation and similarly, deputationists shall not be eligible for appointment by promotion.

Note 2: The period of deputation including period of deputation in any other ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of Central Government shall ordinarily not exceed three years.

Note 3: The maximum age-limit for appointment by Deputation shall not be exceeding 56 years as on the closing date of receipt of applications.

The willing officials may submit their application through proper channel alongwith attested copies of APARs for the last five years, Vigilance Clearance Certificate to the effect that no disciplinary/court/vigilance case is either pending or contemplated against the applicants, through email: dagadmnae.od@nic.in.
