Subject: Grant of dearness relief on revised and un-revised pension/family pension of Nagaland Government pensioners/family pensioners with effect from 01-01-2022.

In continuation to this office circular No. Pen. Co-ordn./Nagaland/Vol.-V/DR-rev&unrev/155 dated 27-01-2022, this is to state that the Government of Nagaland in their FD Memo No. FIN/ROP/REL-8/87(Vol-II) dated 12-05-2022 has enhanced the existing rate of dearness relief on the revised pension/family pension of their pensioners/family pensioners from 31% to 34% with effect from 01-01-2022.

- 2. Payment of dearness relief involving fraction of a rupee shall be rounded off to the next higher rupee.
- 3. Further, in the special seal authority No. Pen/NL-DR/2021-22/139 dated 21-06-2022 of Principal Accountant General (A&E), Nagaland, the existing rate of dearness relief has been enhanced from 196% to 203% with effect from 01-01-2022 in respect of Nagaland Government pensioners/family pensioners whose pension/family pension have not been revised as yet as per this office circular No. Pen. Co-ordn./Nagaland/Vol.-V/Revision/58 dated 11-06-2018 and who are still drawing their pension/family pension as per Nagaland Services (Revision of Pay) Rules, 2010 (this office circular No. Pen. Co-ordn./Nagaland /Vol.-IV/Revision/153 dated 03-11-2010).
- 4. Having been authorised by the Principal Accountant General (A&E), Nagaland in their letter No. Pen/NL-DR/2021-22/139 dated 21-06-2022, it is requested to make necessary arrangement for payment of dearness relief (a) 34% on revised pension/family pension of all eligible Nagaland Government pensioners/family pensioners on their basic pension/family pension with effect from 01-01-2022 after proper adjustment. It is also requested to make necessary arrangement for payment of dearness relief (a) 203% to all eligible Nagaland Government pensioners/family pensioners on their basic pension/family pension with effect from 01-01-2022 whose pension/family pension have not been revised as yet as per this office aforesaid circular dated 11-06-2018, after adjustment of the amount already paid.
- 5. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Nagaland etc."
