*Subject : Enhancement of Freedom Fighters Samman Pension/Dependent pension by Government of Rajasthan with effect from 01-04-2021.*

In continuation to this office circular No. Pen. Co-ordn./Rajasthan/Vol.-VII/FF/140 dated 24-02-2021, this is to state that the Government of Rajasthan in their General Administration (Group-6) Department Order No. P. 4(4)GA/6/2008 dated 26-03-2021 has enhanced the existing Freedom Fighters Samman Pension/Dependent pension from Rs.25,000/- to Rs.50,000/- (Rupees Fifty thousand) only per month with effect from 01-04-2021. The existing rate of Medical Assistance of Rs.5,000/- (Rupees Five thousand) only per month shall be continued.

2. Having been authorized by the Accountant General (A&E), Rajasthan in their letter No. Pension Authority/State/F.F./Guard File/2021-22/1032 dated 12-07-2022, it is requested to make necessary arrangement for payment of enhanced rate of Freedom Fighters Pension @ Rs.50,000/- (Rupees Fifty thousand) only per month and an additional amount of Rs.5,000/- (Rupees Five thousand) only per month as Medical Assistance (i.e. Pension Rs.50,000/- + MA Rs.5,000/- = Total Rs.55,000/- per month) to the Rajasthan Government Freedom Fighters and their dependents with effect from 01-04-2021 after proper adjustment.

3. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Rajasthan etc."
