Applications in the prescribed proforma (enclosed) are invited from retired Supervisors/Asstt. Supervisors/Sr. Accts/Accts for services as Consultants for the post of Accountant in terms of Circular no. 27/2021 circulated vide letter no. 967-Staff(App.)/22-2016 dated 03.08.2021 of the Office of the Comptroller and Auditor General of India.

1. Terms and conditions:

(i) **Name of Post** - Accountant

(i) **Eligibility** - Retired Supervisors/Asstt. Supervisors/Sr. Accts/Accts not beyond the age of 65 as on 01.07.2022.

(ii) **Period of engagement** - The retired employee shall be appointed on a short term contract basis initially for a period of one year from the date of acceptance of contract which can be extended based on his/her performance and requirement of his/her services in this office but not beyond the age of 65 years.

(ii) His/her candidature as Consultant can any time be treated as cancelled on fulfillment of regular staff requirement in this office.

(iii) **Leave:** Retired personnel hired on short term contract basis will not be entitled to any type of leave during the tenure. However paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service to the retired officials hired on short term contract basis.

(iv) **Remuneration** - Remuneration and allowances payable to retired officer/official will be governed by Hqrs circular no. 27/2021 no.967-Staff(App.1)/22-2016 dated 03.08.2021, which is as under;

(a) The retired officer shall be paid a fixed monthly amount, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of the contract.

(b) An appropriate and fixed amount as Transport Allowances for the purpose of commuting between the residence and the place of works shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.

(c) No annual increment/percentage increase, Dearness Allowances and House Rent Allowances shall be allowed during the contract.

(v) **Posting** - The consultant would be posted at Headquarters.

3. Miscellaneous:- All other engagement terms and conditions, as laid down in the Circular no. 27/2021 circulated vide letter no. 967-Staff(App.)/22-2016 dated 03.08.2021 of the Office of the Comptroller and Auditor General of India and General Financial Rules shall be applicable.



Subject: Hiring of retired officers Sr.AOs/AOs/AAOs (Commercial) as consultant on short term contract basis.

In continuation of this office notification no. 2095/DGA/AFWR/Admn/83 dated 04.04.2022 (copy enclosed) vide which applications have been invited from retired Sr. Audit Officers/ Audit Officers/Asst. Audit Officers (Commercial) to work as consultant on short term contract basis in this office as well as our branch offices at Mumbai, Chandigarh & RAO, Hyderabad. It is informed that the Competent Authority has decided to extend the last date of receipt of applications till **14.08.2022** only for branch offices at Mumbai and RAO, Hyderabad.

The following terms and conditions would be applicable to the contractual officers: -

1. The term of engagement shall ordinarily be for an initial period of one year, extendable up to a maximum of five terms of one year each which is subject to performance and requirement of services.
2. Age should not be beyond 65 years as on 14.08.2022.
3. Remuneration and allowances payable will be governed by OM No. 3-25/2020-E.IIIA dated 09.12.2020, issued by the Department of Expenditure, Ministry of Finance, Government of India, New Delhi, which is as under
 - a) The retired person engaged on short-term contract basis shall be paid a fixed monthly amount, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of the contract.
 - b) The retired person will not be entitled for annual increment/percentage increase, house rent allowance, residential accommodation, dearness allowances during the contract.
 - c) An appropriate and fixed amount as transport allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.
4. Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service to the retired officials hired on short term contract basis. Accumulation of leave beyond a calendar year may not be allowed. However, absence during curfew, bandh, strike, lockdown should be dealt with in a similar way as in the case of serving officers/officials as these are events beyond the control of any individual. If retired officers hired on short term contract basis remain absent, beyond paid leave in a month for reasons other than those indicated above, his/her remuneration shall be deducted on pro-rata basis as under:

Fixed monthly remuneration * No. of days of absence on working days.
