Calling for applications from fresh / repeater candidates intending to appear in SAS/RA/CPD-I, II & III Examination-2 of 2022.

वर्ष 2022 हेतु मुख्यालय के परीक्षा अनुसूची के अनुसार, वर्ष 2022 की एस.ए.एस/आर.ए/सी.पी.डी परीक्षा- 2, दिनांक 14 से 19 नवंबर 2022 तक आयोजित की जाएगी। प्रधान महालेखाकार (लेखापरीक्षा-I) का कार्यालय एवं निदेशक/ केंद्रीय राजस्व लेखापरीक्षा शाखा कार्यालय, भुवनेश्वर के पात्र अधिकारी/कर्मचारी जो एस.ए.एस. (सिविल/वाणिज्यिक लेखा परीक्षा)/राजस्व लेखा परीक्षा/सी.पी.डी-I/II/III परीक्षाओं में सम्मिलित होने के लिए इच्छुक हैं, वे अपने आवेदनों को संलग्न निर्धारित प्रपत्र में उचित माध्यम से अग्रेषित कर सकते हैं।

As per Headquarters Examination Schedule of 2022, the SAS/RA/CPD Examinations-2 of 2022 will be held from 14th to 19th November 2022. The eligible Officers/officials of O/o the PAG(Au-I) & Director /CRA Branch Office, BBSR who are desirous of appearing SAS (Civil/Commercial Audit)/Revenue Audit/CPD-I/II/III examinations may forward their applications through proper channel in the prescribed performa enclosed.

एस.ए.एस./आर.ए./सी.पी.डी.- I, II और III परीक्षा 2022 के लिए अधिकारियों की पात्रता निर्धारित करने की कट ऑफ तिथि 1 सितंबर 2022 होगी। पात्र परीक्षार्थी जिन्होंने किसी विशेष क्षेत्र कार्यालय में न्यूनतम 2 वर्ष की निरंतर सेवा की है और सफलतापूर्वक अपनी परिवीक्षा अवधि पूरी कर ली है, वे एस.ए.एस. परीक्षा में सम्मिलित होने के लिए पात्र हैं। इच्छुक परीक्षार्थियों से अनुरोध है कि वे उक्त परीक्षा में सम्मिलित होने से पूर्व, एस.ए.एस./आर.ए./सी.पी.डी. I और II परीक्षाओं में सम्मिलित होने के लिए पात्रता मानदंड निर्धारित करने के लिए एम.एस.ओ. (प्रशासन) I के संशोधित अध्याय IX एवं सीएजी के वेबसाइट पर उपलब्ध मुख्यालय के परीक्षा स्कंध के परिपत्रों का अनुसरण करें।

The cut off dates for determining the eligibility of the officials for SAS/RA/CPD I, II & III Examination 2 of 2022 will be 1st September 2022. The eligible candidates who have put in a minimum of 2 years of continuous service in a particular field office and has successfully completed their probation period are eligible to appear in the SAS Examination. The intending candidates are requested to follow the revised Chapter IX of MSO (Admn) I for determining the eligibility criteria for appearing the SAS/RA/CPD I

& II Examinations and Headquarters Office Examination Wing Circulars available in C&AG website before appearing for the said examination.
