





2. The Executive Engineer, Tubewell Division, Jaunpur. Shri Deepak Kumar, Divisional Accountant (Probationer), appointed on 15.09.2022 (forenoon), is hereby posted to above division. He has been relieved from this office on 16.09.2022 (afternoon). His pay will be fixed at the stage of Rs.35400/- in 'Level-6 of the Pay Matrix'.
