CIRCULAR

Headquarters vide letter No. 421/13-Exam/Examination-1/2022 dated 27-09-2022 has intimated that the registration SAS/IE/CPD-I, II & III Examinations in Exam-2 of 2022 scheduled to be held from **15-12-2022 to 21-12-2022**, will commence on **03-10-2022** and will end on **21-10-2022**. The date-sheet of the examination will be intimated by the Headquarters in due course. The cut-off date for eligibility for the examination is **01-09-2022**.

Eligibility:

1. For SAS examination, confirmed Group C officials with 2 years of continuous service in one or more post(s) in a particular field office is eligible to appear for the SAS examination.
2. For CPD examination:-
 - a. All Sr. AOs are eligible to take the CPD-I examination. AAOs are eligible to appear for the CPD-I examination after completion of four years of continuous service in the grade.
 - b. The CPD-II examination can be taken by the Sr. AO/AOO after elapse of four years from qualifying their CPD-I examination.
 - c. The CPD-III examination can be taken by the Sr. AO/AOO after elapse of three years from qualifying their CPD-II examination.
3. For Incentive Examination for Sr. AOs/AOOs, all Sr. AOs are eligible to appear for the Incentive Examination. AAOs should have put in one year of continuous service in the grade to appear for the examination.

For the registration process viz., the first part, the basic data i.e. Name, Date of Birth, Category, registered mobile number etc., as mentioned in the Service Books of the candidates will be entered into the first part of the registration form by the Admn-I Section. A login ID and password generated by the system will be sent to the registered mobile number of the candidate. Thereafter, the candidate will complete the second part of the registration by themselves. The Exam Registration Officer (ERO) will verify and validate the data entered into the online registration form to enable the Principal Accountant General to approve their candidature. The registration process including ERO validation/HoD approval will be completed by **31-10-2022**.

The attempt of a candidate would be counted once she/he registers for the exam and there is no scope of withdrawal. The candidates who are on deputation to other offices within the department should submit their applications directly to this section under intimation to Administration of the borrowing offices. Such candidates should make all exam related communications to Admn-I Section of this office directly for timely completion of registration process/other examination related issues. No extension of timelines as fixed by the Headquarters will be considered.
