It is hereby notified that 2nd term Divisional Accountants' Grade Examination 2022 is proposed to be held during the fourth week of November, 2022. The detailed programme with the dates and the venue of the examination will be announced in due course.

Senior Accounts Clerks who have already completed or will complete three years of service and direct recruit Divisional Accountant (Probationer) who have already completed or will complete one year of service as on 01.11.2022 may apply in the prescribed pro-forma (ANNEXURE-I) duly forwarded by their respective Divisional Officers by e-mail latest by 04.11.2022.

Under no circumstances applications received after the said date will be entertained.

The last date for withdrawal of candidature for the aforesaid examination shall be 07.11.2022.

Applications of only those candidates who fulfill conditions as laid down in chapter VII of the C&AG's M.S.O. Volume -I would be recommended.

Direct recruit Divisional Accountant (Probationer) will have to appear in all five papers as mentioned below, however, Sr. Accounts Clerks will have to appear in four papers excluding Paper-I.

Further, in terms of Headquarters' Examination Wing Circular No. 10 of 2022 issued vide no 145/07-Exam/Clarification MCQ Pattern/2022 dated 24/03/2022, every paper will contain 100 MCQ with one mark for each question. There is a provision of negative marking to the extent of 0.25 (25 percent) for each incorrect answer.

Unless otherwise communicated, the candidates should answer questions in the D.A.G.E. with reference to the new Heads of Accounts.
