Subject:- New Sports Policy for promoting sports in IA&AD. Madam / Sir,

I am directed to invite a reference to the subject cited above and to enclose herewith the revised list of probable players of CAG's Hockey Team.

In this regard, it is stated as follows:

- (a) The players mentioned in the list may be relieved of their duties from 2.00 pm onwards daily throughout the year for practice and maintain fitness/form for the tournament and not cancel their practice order on the exigency of work. This list will remain valid till issue of new list.
- (b) The players who are not in the ibid list but will represent AG's Team during IA&AD Zonal/Inter-zonal tournaments may be allowed time relaxation from 3 pm onwards daily throughout the year under supervision/monitoring of one sr.player (to be nominated by the respective IA&AD office). The list will be revised by the respective IAAD office every year before commencement of IAAD tournaments.
- (c) The concerned players availing time relaxation (2 pm/3 pm onwards daily) will intimate in writing to their respective offices regarding the address of their practice/fitness venue. In case of any change of their place of practice, the same should be intimated by them immediately to their offices.
- (d) The players mentioned in the list may be allowed to participate in any league/tournament and referred to Hqr's office for 'NOC'/permission. However, permission in respect of those players who are not in the ibid list may be granted by the Heads of the offices of the concerned players. The players recruited under sports quota can play from any State. The matter regarding period of absence for participation in any tournament as player/coach/manager may be treated as 'On duty' w.r.t DoPTs' OM dated 16.07.1985 and OM dated 07.11.1988 (national/international importance) and regularized by Spl. CL (maximum limit 30 days) in case of tournaments of local importance (district level).
- (e) The concerned players will intimate in writing to their respective offices regarding the address of their practice venue. In case of any change of their place of practice, the same should be intimated by them immediately to their offices. All the concerned players mentioned in the list will do their practice under supervision of one sr. player (mentioned in the list) at the respective station who will submit a monthly report to the Welfare Officer/Sr.AO(Admn.) of their respective offices regarding the attendance and fitness of the players. In case of a station where no such sr. player of hockey discipline is available, the duty may be assigned to sr. player of any discipline by the respective IAAD office. Further, in case of non-availability of even sr. player of any discipline, the duty may be assigned to Welfare Officer/Sr.AO/Admn. If any player is found to be absent in practice without any intimation/reason, the same may be intimated to Hqrs' office for exclusion of name of the concerned player from the list followed by cancellation of practice order.

The above instructions may please be notified to all concerned suitably and implemented from the date of receipt of this letter.
