Subject: (i) Grant of Dearness Relief to the Maharashtra Government pensioners/family pensioners with effect from 01-01-2022; and (ii) Grant of Dearness Relief to the Maharashtra Government pensioners/family pensioners on their pre-revised pension/family pension with effect from 01-01-2022.

In continuation to this office circular No. Pen. Co-ordn./Maharashtra/Vol.-VII/DR&Arrear/55 dated 14-06-2022, this is to state that the Government of Maharashtra in their Finance Department Resolution No. DRP-2022/CR.47/SER-4 dated 17-08-2022 has sanctioned dearness relief to their pensioners/family pensioners as under:

Date of effect	Rate of Dearness Relief per month
01-01-2022	34% of basic pension/family pension

2) Besides, in continuation of this office circular Pen. Co-ordn./Maharashtra/Vol.-VII/DR-un-rev&Arrear/56 dated 14-06-2022, this is to state that the Government of Maharashtra in their FD Resolution No. DRP-2022/CR.47/SER-4 dated 17-08-2022 has sanctioned dearness relief to their pensioners/family pensioners drawing un-revised pension/family pension (i.e. as per Sixth Pay Commission) as under:

Date of effect Rate of Dearness Relief per month
01-01-2022 203% of basic pension/family pension

- 3) The above rates of dearness relief would mutatis mutandis apply to those pensioners/family pensioners of Recognised and Aided Educational Institutions, Agricultural/Non-Agricultural Universities and Affiliated Non-Government Colleges to whom the pension scheme is made applicable.
- 4) The above rates will also be applicable to the pensioners/family pensioners of Zilla Parishads.
- 5) Payment of dearness relief involving fraction of a rupee shall be rounded off to the next higher rupee.
- 6) Having been authorised by the Accountant General (A&E)-I, Maharashtra in their authority No. P.A. I/Governmental/G.R.No. P/22/Govt/61205185/Maharashtra/Ch.5/OW No. 61081301 dated 16-09-2022, it is requested to make necessary arrangement for payment of dearness relief to all eligible Maharashtra Government pensioners/family pensioners @ 34% on their revised basic pension/family pension in cash with effect from 01-01-2022 following the instructions laid down above and after proper adjustment. It is also requested to make necessary arrangement for payment of dearness relief to all eligible Maharashtra Government pensioners/family pensioners @ 203% with effect from 01-01-2022 on their un-revised basic pension/family pension after adjustment of the amount already paid.
