Circular No. Pen. Co-ordn./Jammu & Kashmir/Vol.- III/DR/120 Date : 20-10-2022

Subject : Grant of Dearness Relief to the Jammu & Kashmir Government pensioners/family pensioners with effect from 01-07-2018, 01-01-2019, 01-07-2019, 01-07-2021 and 01-01-2022.

In continuation to this office circular No. Pen. Co-ordn./Jammu & Kashmir/Vol.- III/Revision/90 dated 31-08-2022, this is to state that Government of Jammu & Kashmir in their Order Nos. 390-F of 2018 dated 13-09-2018, 185-F of 2019 dated 07-03-2019, 457-F of 2019 dated 24-10-2019, 305-F of 2021 dated 17-11-2021 and 113-F of 2022 dated 20-04-2022 have sanctioned dearness relief to their pensioners/family pensioners as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-07-2018	9% of basic pension/family pension
01-01-2019	12% of basic pension/family pension
01-07-2019	17% of basic pension/family pension
01-07-2021	31% of basic pension/family pension
01-01-2022	34% of basic pension/family pension

2. Payment of dearness relief involving a fraction of 50 paise and above shall be rounded to the next rupee and the fractions of less than 50 paise shall be ignored.

3. Personal pension, if any, will not be taken into account for determining dearness relief on pension.

4. The other provisions governing grant of dearness relief on pension/family pension such as regulation of Dearness Allowance during employment/re-employment, where more than one pension is drawn etc. and other provisions of the existing orders/rules (as are not in conflict of the provisions of this order) shall continue to remain in force.

5. Having been authorised by the Principal Accountant General (A&E) Jammu & Kashmir in their authority No. Pen/A/c/PNR-4/2022-23/1398-1407 dated 14-09-2022, it is requested to make necessary arrangement for payment of dearness relief @ 9%, 12%, 17%, 31% and 34% on basic pension/family pension with effect from 01-07-2018, 01-01-2019, 01-07-2019, 01-07-2021 and 01-01-2022 to all eligible Jammu & Kashmir Government pensioners/family pensioners keeping in view the instructions laid down above and after making proper adjustment.
