HGV-102017-O-1201-P dated 18-08-2022 and HGV-102017-O-1201-P dated 22-08-2022 has sanctioned Temporary Increase (dearness relief) on pension/family pension of their pensioners/family pensioners drawing pension/family pension as per 6th Pay Commission (this office circular No. Pen.Co-ordn./Gujarat/Vol.-V/Revision/72 dated 25-08-2009), as under:

1	Date of effect	Rate of Temporary Increase per month
	01-07-2021	196% of basic pension/family pension
T	01-01-2022	203% of basic pension/family pension

2. Temporary Increase at the rates indicated in above table will also be admissible on the additional basic pension/family pension available to older pensioners/family pensioners based on their age.

3. Payment of Temporary Increase involving a fraction of a rupee shall be rounded off

to the next higher rupee.

4. Other provisions governing grant of Temporary Increase to pensioners such as regulations of dearness relief during employment/re-employment, regulation of Temporary Increase, where more than one pension is drawn etc. will remain unchanged.

- 5. Having been authorised by the Principal Accountant General (A&E), Gujarat in their letter Nos. Pension/G.R./Special Scal/02,03,04,05/2022-23/OW No. 568 dated 25-08-2022 and Pension/GRs/74 dated 30-09-2022, it is requested to make necessary arrangement for payment of Temporary Increase to all eligible Gujarat Government pensioners/family pensioners on their pre-revised basic pension/family pension @ 196% with effect from 01-07-2021 and @ 203% with effect from 01-01-2022 after proper adjustment.
