Subject : Grant of dearness relief to the Goa Government Freedom Fighter pensioners/family pensioners with effect from 01-01-2022.

In continuation to this office circular No. Pen. Co-ordn./Goa/Vol.-V/DR-FF/97 dated 12-09-2022, this is to state that the Government of Goa in their FD Order No. 11/4/2012-HD(G)/7738 dated 06-09-2022 has adopted the rate of dearness relief announced by the Central Government in respect of their Freedom Fighter pensioners/family pensioners, as under :

Date of effect	Rate of dearness relief per month
01-01-2022	203% of basic pension/family pension

2. Payment of dearness involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Director of Accounts, Government of Goa in their letter No. DA/PA-I/Pens/22-23/TR-648/DR-1579 dated 21-09-2022, it is requested to make necessary arrangement for payment of dearness relief on pension/family pension to the Goa Government Freedom Fighter pensioners/family pensioners @ 203% with effect from 01-01-2022 after proper adjustment.

4. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Goa etc."
