In continuation to this office circular No. Pen. Co-ordn/Puducherry/Vol.-III/DR&FMA-Arrear/22 dated 27-04-2022, this is to state that the Government of Puducherry in their GO Ms. No. 71/FD/F3/A2/2022-23 dated 14-10-2022 has revised the rate of dearness relief for their pensioners/family pensioners as follows:

Date of effect	Rate of Dearness relief per month
01-07-2022	38% of basic pension/family pension

2. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Directorate of Accounts and Treasuries, Puducherry in their letter No. DAT/Pen-I/A1/D.R/2022 dated 18-10-2022, it is requested to make necessary arrangement for payment of dearness relief @ 38% to all eligible pensioners/family pensioners of Government of Puducherry with effect from 01-07-2022 after proper adjustment.
