
Subject: Modified logo of the CAG's Organization.

**Subject: Adoption of distinct logo for the Indian Audit and
Accounts Department.**

Sir/ Madam,

I am to invite a reference to this office Circular No. 13 issued vide letter No. 1034-O&M/126-85 dated 19 September, 1988 on the implementation of the unique symbol as the distinct emblem of the IAAD. This logo was discontinued vide circular No. I issued vide letter No.53-PD(S)/Logo/97 dated 20 October, 1997.

2. Comptroller and Auditor General of India have now approved a new logo for Indian Audit and Accounts Department. Information on selection of the logo and the depiction of various ingredients constituting the logo are explained in the Annexure. This logo has already been forwarded by email to all concerned by the AC (N) on 12 November, 2010. Contents of the logo may be given wide publicity within the department.

3. Type of usage

The new logo may be used by all the offices in the Indian Audit and Accounts Department in respect of the following:

- Visiting cards
- Invitation cards
- File covers, note pads etc
- Official publications of the department
- Advertisements, banners, pamphlets, background displays etc
- Crests, flags with such modification as considered necessary
- Websites of the department
- Certificates issued by the department
- Signages, shields, backdrop panels, advertisements

- Departmental vehicles (optional)
- Audit Reports
- For any other purpose as deemed fit without violating the provisions of the State Emblem of India (Prohibition of improper use) Act, 2005 and the State Emblem of India (Regulation of Use) Rules, 2007.

4. Exception:

For identity cards and certain types of official stationery viz, D.O letters, Ordinary letters, the State Emblem of India will continue to be used.

5. Place of display

In all types of usage as referred to above, the logo may be exhibited preferably on the top left or as is being followed by various departments of the Government of India. **However, in the Audit Reports, the logo may be used on the top Left hand side of the outer page along with the emblem of the Government of India / the respective State Government which will be placed on the top Right hand side.**

6. Restrictions on usage:


Since the State Emblem of India has been incorporated in the logo of IAAD, use of the logo will be regulated by the provisions of the State Emblem of India (Prohibition of improper use) Act, 2005 and the State Emblem of India (Regulation of Use) Rules, 2007.

7. No separate colour scheme is proposed for the headquarters and the field offices as was done in the past. Hence the same colour combination of the logo may be followed by all through the department.

8. All other instructions in vogue on the use of logo may be strictly observed. In case of any difficulty, the matter may be referred to Headquarters.
