CIRCULAR

Subject: Option for choice of place of Posting for Annual Transfers in respect of Divisional Accounts Officer's/Divisional Accountant Grade during the year 2022-23.

All the Senior Divisional Accounts Officers/Divisional Accounts Officers-I&II, DAs who are eligible for Annual Transfer are directed to submit the option of '04' (Four) preferences of station of posting keeping in view of their grade for the year 2022-23. Out of '04' (Four) choices '01' (One) preference should be compulsorily opted for Naxal affected districts. Officials are strictly bounded to opt the city of their choice where the vacancy is available according to their entitled grade. Officials would be posted at a division after considering his last three years performance as well as in view of any complaint/DE cases pending against him.

The posting will be subject to availability of vacancy and administrative exigencies.

1. The Option Forms duly filled in should be sent in sealed cover superscribing "**Confidential- Option for Transfer and Posting of DAOs/DAs 2022-23**" by speed post/registred post /by hand to Shri Purna Chandra Majhi, Principal Accountant General (A&E) Chhattisgarh, Zero Point, Baloda Bazar Road, Post Office: VidhanSabha,Raipur-492005,
2. Duly filled Option Form should reach latest by **10.01.2023**
3. A list of vacant divisions indicating the grade of the divisions is also attached. Option Form and notification of vacant divisions along with the grading is uploaded in the official website.
4. Giving only a single station as option will be treated as **NO OPTION** for Annual Transfer 2022-23
5. Only one Option Form will be accepted from each official. The option form which is received first in the office will only be considered.
6. Option Forms received after the due date and incomplete option forms submitted will not be entertained and they are liable to be considered as candidates with "No Option".


