Government servants are required to file their returns by 31st January 2023, in the prescribed formats (copy enclosed) in terms of Rule 18(4) of the CCS (Conduct) Rules.

In terms of Rule 18 (3) of CCS (Conduct) Rules, "failure to submit the Annual Property Return by 31st January shall entail denial of vigilance clearance and the persons concerned shall not be considered for empanelment for senior level posts in Government".

The officers/ officials who are on deputation in the DA cadre from this office are requested to submit their Annual Property Return in the official websiter (http://cag.gov.in/ae/west-bengal/en) through "Employee Login" in the following path, (Apply/Declare >> Asset Declaration for self and Asset declaration for dependent) latest by 31.01.2023 in terms of Office order (Admn. Series) No. Admn-I/1336-IV/2022-23/466 dated 03.01.2023.
