Sr. No.	Name of the Post & Pay Level	Eligibility
1.	Assistant Accounts Officer, Level-08	Holding the analog post of Assistant Accounts Officer/Asstt. Audit Officer in the pay level-08 of pay matrix.
2	Accountant, Level-05	Holding the analogous post of Accountant/Auditor in the Pay level-5.
3	DEO Grade-A, Level-04	Holding the analogous post on regular basis in the parent office.
4	Clerk, Level-02	Holding the analogous post on regular basis in the parent Office.

Terms and conditions:-


1. The officials in the feeder cadre who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation basis. Similarly, deputationist shall not be eligible for consideration for appointment on promotion.
2. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on closing date of receipt of applications.
3. Period of deputation shall be for one year initially and can be extended further as per availability of vacancies and suitability of the candidate.

attested copies of APARs for the last five years and vigilance clearance certificate to this office by 17.03.2023.
