- 3. In case air-conditioners are not fitted, 10% of the rate shall be discounted.
- 4. When an IA&AD employee (serving/retired) books only one room and visitors' combination includes the IA&AD employee as well as his/her near relative, the rate applicable to the IA&AD employee is chargeable; whereas booking is only for near relatives of the IA&AD employees, then rates applicable for near relatives is chargeable.
