Subject:- Grant of dearness relief on pension / family pension @ 42% w.e.f 01/01/2023 to the retired Judges of High Courts/Supreme Court and family pensioners of such Judges

In continuation to this office circular No Pen. Co-ordn./66 Vol.III/134 dated 14/11/2022, it is stated that Government of India, Ministry of Law and Justice (Department of Justice) vide their letter No L-19016/01/2018-Jus. dated 21/04/2023 have granted revised rate of Dearness Relief @ 42% with effect from 01/01/2023 to the retired Judges of High Courts/Supreme Court and family pensioners of such Judges in supersession of the existing rate.

The payment of dearness relief involving a fraction of rupee shall be rounded off to the next higher rupee.

All concerned Pension Disbursing Officers are, therefore, requested to make necessary arrangement for payment of Dearness Relief to the above categories of pensioners/family pensioners at the rate and from the date mentioned above.
