*Subject : Grant of dearness relief to Arunachal Pradesh Government pensioners/
family pensioners with effect from 01-01-2023.*

In continuation to this office circular No. Pen. Co-ordn./Arunachal Pradesh/Vol.-V/DR/169 dated 29-12-2022, this is to state that the Government of Arunachal Pradesh in their Finance Department OM No. Estt-II-14/3/2022-Estt-II-FPID/03 dated 25-04-2023 have sanctioned dearness relief to their pensioners/family pensioners at the rate and from the date as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-01-2023	42% of basic pension/family pension

2. Payment of dearness relief involving fraction of a rupee shall be rounded off to the next higher rupee.

3. All other terms and conditions as enunciated in the Government of India, Ministry of Personnel, Public Grievances & Pensions' OM No. 42/07/2022-P&PW(D) dated 08-10-2022, which has already been communicated to all pension disbursing authorities vide this office circular No. Pen. Co-ordn./55 Vol.VII/142 Vol.III/65 Vol.V/66 Vol.III/5 dated 11-04-2023, shall remain unchanged.

4. Having been authorised by the Director of Audit & Pension, Government of Arunachal Pradesh in their letter No. DAP/PEN-II/99-2000/VOL-I/105-06 dated 28-04-2023, it is requested to make necessary arrangement for payment of dearness relief @ 42% on basic pension/family pension to all eligible Arunachal Pradesh Government pensioners/family pensioners with effect from 01-01-2023 after proper adjustment.

5. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Arunachal Pradesh etc."
