**Subject : Grant of dearness relief with effect from 01-07-2022 and 01-01-2023
on pension/family pension of the retired Judicial Officers of
Government of Madhya Pradesh.**

In continuation to this office circular No. Pen. Co-ordn./M P/Vol.-VII/DR-Judi/65 dated 28-06-2022, this is to state that the Government of Madhya Pradesh in their Order No. 4343/21-B(1)/2022 dated 02-11-2022 and 1657/21-B(1)/2023 dated 18-04-2023 has sanctioned dearness relief on basic pension/family pension including additional pension/family pension at par with the Central Government for their retired Judicial Officers at the rate and from the date mentioned below :

<i>Date of Effect</i>	<i>Rate of Dearness Relief per month</i>
01-07-2022	212% of basic pension/family pension
01-01-2023	221% of basic pension/family pension

2. Having been authorized by the Accountant General (A&E) - II, Madhya Pradesh in their letter No. Pension/536A dated 30-05-2023, it is requested to make necessary arrangement for payment of dearness relief @ 212% and 221% on basic pension/family pension of the retired Judicial Officers of Government of Madhya Pradesh with effect from 01-07-2022 and 01-01-2023 respectively after proper adjustment.
