The Next Departmental Examination for Auditors is scheduled to be held in this office during the month of August, 2023 w.e.f 22/08/2023 to 25/08/2023 on the following subjects (The pattern of examination has been revised as Multiple Choice Questions {MCQ} except Information Technology Practical) as detailed -

- 1. Book-Keeping and Company Accounts. (On 22<sup>nd</sup> August, 2023)
- 2. Commercial & Government Auditing. (On 23rd August, 2023)
- 3. Commercial Law & Service Regulations. (On 24th August, 2023)
- 4. Information Technology Practical. (On 25th August, 2023)
- 1. The candidates, who intend to take the said examination in August, 2023 should submit their willingness in the enclosed Application Form with recommendation of the Branch Officer on or before 28/08/2023 Applications received after due date will not be entertained. The applications of candidates stationed outside Delhi may be sent by Registered Post to the Senior Audit Officer (Administration) through the concerned Branch Officers.
- 2. All directly recruited Auditors who have completed 01(one) year of continuous service on 1<sup>st</sup>, August, 2023 or before will be eligible to appear in the examination. Clerks promoted on seniority basis may take the examination immediately after their promotion. They may, however, not to take the examination, if it is held within 90(ninety) days of their promotion.
- 3. All concerned Auditors are informed that every one of them has to qualify the examination within 06 (six) consecutive chances (of examinations) after the date of his/her eligibility to appear for the first time in the examination, failing which he/she will be liable to be reverted to the grade from which promoted/discharged from service. The reverted clerks are required to qualify in the examination within 03(three) consecutive chances in two years after the reversion.
- 4. The Auditors who have been promoted from the cadre of clerk are required to pass the Departmental Exam within the prescribed number of chances failing which the official would be reverted and would be considered for promotion after 05(five) years from the date of reversion.

- 5. As per Headquarters office Circular No 06- Staff (App I)/2022 dated 04/02/2022, "Graduate Group 'C' officials with combined regular service of 3 years are also eligible to appear in this examination provided the eligibility criteria etc. are fulfilled for consideration of their promotion as per rules.
- Clerks/MTS transferred on unilateral basis will be eligible to appear in the examination only after completing 03(three) years regular service in the new office.
- 7. Condonation of deficiency will be considered up to a maximum of 60(sixty) days in computing qualifying service for directly recruited auditors for appearing in the examination. The relevant date for this purpose is 01-08-2023.
- Passing the examination is a pre-requisite for becoming eligible for confirmation, promotion to the higher scale in Senior Auditor cadre etc. provided their work and conduct is satisfactory.
- Comptroller and Auditor General of India has decided to permit optional use of Hindi as an alternative medium for answering the papers subject to the following conditions -
  - (i) The candidates are allowed the option to answer the examination in Hindi or English as they may choose provided the option is exercised and communicated at the time of applying for the examination
  - (ii) It is also made clear to the candidates that no concession or consideration of any kind may be expected on the ground that Hindi translation of Codes and Rules are not supplied.
