INSTRUCTION TO THE CANDIDATES

- 1. Candidates are expected to write only on the Question booklet supplied.
- 2. The index number assigned to each candidate should be distinctly written both in figure and words only on space provided at the top of the Question booklet supplied and nowhere else. Index number and Name should not appear anywhere in the Question booklet except the space provided.
- 3. No candidate may enter the examination hall later than 10 minutes after examination begins nor depart the examination hall earlier than 10 minutes before examination ends.
