Subject : Grant of dearness relief to the pensioners/family pensioners of Tripura Government Judicial Services with effect from 01-01-2023.

In continuation to this office circular No. Pen. Co-ordn./Tripura/Vol.- VI/DR-Judi/206 dated 16-03-2023, this is to state that the Government of Tripura in their Memo No. F.5(6)-FIN(G)/79(Part-II)/61-71 dated 08-05-2023 has enhanced the dearness relief from the existing rate of 212% to 221% with effect from 01-01-2023 to the pensioners/family pensioners of their Judicial Services.

Having been authorised by the Accountant General (A&E), Tripura in their letter No. Pen-1/Tripura Relief/Judicial/2023-24/15813-20 dated 18-07-2023, it is requested to make necessary arrangement for payment of dearness relief @ 221% to all eligible pensioners/family pensioners of Tripura Government Judicial Services with effect from 01-01-2023 after proper adjustment.
