Subject : Grant of dearness relief to the Goa Government Freedom Fighter pensioners/family pensioners with effect from 01-01-2023.

In continuation to this office circular No. Pen. Co-ordn./Goa/Vol.-V/Rev-FF/21 dated 16-05-2023, this is to state that the Government of Goa in their Department of Home (General) Order No. 11/4/2012-IID(G)/1596 dated 08-06-2023 has adopted the rate of dearness relief announced by the Central Government in respect of their Freedom Fighter pensioners/family pensioners, raising it from 38% to 42% with effect from 01-01-2023.

2. Payment of dearness involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Director of Accounts, Government of Goa in their letter No. DA/PA-I/Pens/23-24/TR-532/DR-812 dated 19-07-2023, it is requested to make necessary arrangement for payment of dearness relief on pension/family pension to the Goa Government Freedom Fighter pensioners/family pensioners @ 42% with effect from 01-01-2023 after proper adjustment.

4. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Goa etc."
