

**CIRCULAR**

As per the provisions contained in clause II of Rule 18(1) of C.C.S (conduct) Rules 1964 read with G.I.D. No.22&23 there under, every Government Servant belonging to any service or holding any post is required to submit an Annual Property Return statement in respect of every calendar year by 31<sup>st</sup> January of the next year giving full particulars regarding the immovable property inherited by him/her or owned or acquired by him/her or held by him/her on lease or mortgage either in his/her name or in the name of any member of his/her family or any member of his/her family or in the name of any other person.

The default DAOs/Sr.DAs as per list shown in Annexure are directed to submit their Annual Property Return statement for the year 2021 & 2022 by 30.09.2023 positively and failure to adhere to the above time schedule would invite the denial of vigilance clearance in accordance with Rule 18, GID (31).

Further action will also be initiated as per the GI Dept.Per.&Trg.O..M.No.11013/12/93-Esst(A),dated 24<sup>th</sup> January 1994.
