Sub: Filling up of posts of Senior Audit Officer (Civil) on deputation basis in O/o the Principal Accountant General (Audit), Andhra Pradesh.

Applications are invited to the post of Senior Audit Officer (Civil) in this office on deputation basis on usual terms and conditions stipulated in DoPT OM No. F.No.2/6/2016-Estt. (Pay-II) dated: 22.04.2016 as amended from time to time.

Eligibility criteria for deputation is as under:

| 1 | Senior Audit officer (Civil) | Level-10 | 1.Officers working in IA&AD offices located anywhere in India: i. Holding analogous post on regular basis in the parent cadre or department; or ii. Possessing atleast two years of regular service in level - 9 (Rs. 53100-167800) of pay matrix in the grade or equivalent. |

The terms of deputation and selection process:

1. The period of deputation shall be initially for one year which may be extended on yearly basis subject to performance of the official concerned and administrative convenience.
2. The Officers can be repatriated at any time as per the administrative convenience or if his/her performance is found unsatisfactory.
3. Maximum age limit should not exceed 56 years as on closing date of application.
4. The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.
5. While on deputation, the officers have the option either to fix their pay in the deputation post i.e., Level-10 (Rs.56100-177500) of the pay matrix or will be entitled

for deputation allowance in accordance with the relevant instructions of DoPT as amended from time to time.

6. Screening of applications and selection of officers will be done solely at the discretion of Competent authority.
7. Any of the terms and conditions mentioned above can be varied/relaxed at the discretion of this office.
