All Officers and officials are required to furnish a statement of immovable properties held by them as on 31.12.2023 as required in Rule 18 (1) (i) (ii) of CCS (Conduct) Rules in the form enclosed. The statement in respect of dependants may be furnished in separate form. The statements may be furnished to Administration Section latest by 31.01.2024.

While furnishing Immovable Property Returns, it may be ensured that usage of phrases such as "same as last year" or "no change" are avoided and full particulars of the immovable property inherited/owned/acquired or held are to be furnished. **The deadline should be strictly adhered to.**

Form for statement of immovable property is available in office intranet (*folder in Public*) and office website.
