As per para-7 (5) of Allotment of Government Residences (IA&AD) Rules, 2021

1. If any allottee fails to accept the allotment of a residential accommodation within eight days from the date of allotment of the said accommodation, or fails to take possessions of that accommodation within five working days from the date of receipt of the letter of authorization, she /he shall be debarred to apply for accommodation for a period of three months from the date of non-acceptance of allotment subject to payment of one month's licence fee for that type of accommodation.
2. The date of non-acceptance of allotment shall be calculated from the date of allotment.
3. If an allottee occupying a lower type of accommodation refuses to accept the offer of an accommodation of the type for which she / he is eligible under these rules, she/ he shall be permitted to continue in the previously allotted accommodation;
4. Provided that such allottee shall not be eligible for another allotment for a period of six months from the date of non-acceptance of such allotment.
5. The allottee is to deposit security money as per applicable rule for new electricity connection in respect of the quarter under bulk supply scheme. Energy charges including arrears at rates revised from time to time basing on the tariff revision by the Distribution Company will be deducted from the salary and allowances of the employee for allotment of a quarter covered under the bulk-supply scheme. HLF, Water charges and any other dues will also be recovered from him at the applicable rates.

**Further it is to inform to the allottees that they may apply Quarter through online for the period from February 2024 till regular Quarters has not allotted in their favour.**

**NB:** *In case of increase in the number of newly recruited lady Officers/Officials Estate Cell will enhance the co-allottees number in quarter No. at Sl.1 & 2 of the table.*
