Subject: Grant of dearness relief to the pre-01-01-2016 pensioners/family pensioners of Tripura Government Judicial Services at the rate commensurate to the rate payable to the Central Government employees from time to time with effect from 01-01-2016 onwards.

In continuation to this office circular No. Pen. Co-ordn./Tripura/Vol.- VI/Revision-Judi/104 dated 19-10-2023, this is to state that the Government of Tripura in their Law Department Addendum No. F.1(1)-SECY/LAW/MISE/2019 (Part-I)/254-285 dated 14-08-2023 has decided that the retired pre-01-01-2016 Judicial Officers/family pensioners shall be entitled to get dearness relief (DR) on their revised basic pension/family pension at the rate commensurate to the rate of dearness relief payable to the Central Government employees from time to time with effect from 01-01-2016.

2. As such, dearness relief to such pensioners/family pensioners shall be paid at the rate and from the date mentioned below:
