*Subject : Grant of dearness relief to the Mizoram Government pensioners/family pensioners with effect from 01-04-2023 and 01-09-2023.*

In continuation to this office circular No. Pen. Co-ordn./Mizoram/Vol.- IV/DR/190 dated 28-03-2022, this is to state that Government of Mizoram in their FD Memo No. G.17011/6/2019-F.APF dated 21-03-2023 and G.17011/6/2019-F.APF dated 15-09-2023 have sanctioned revised rates of dearness relief to their pensioners/family pensioners as under :

Date of effect	Rate of dearness relief per month
01-04-2023	32% of basic pension/family pension
01-09-2023	36% of basic pension/family pension

2. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Director, Local Fund Audit & Pension, o/o the Chief Controller of Accounts, Accounts & Treasuries, Government of Mizoram in their authority No. G.19020/108/01-CCA(P)/268 dated 01-08-2023, Director, Local Fund Audit & Pension, Accounts & Treasuries, Government of Mizoram in their authority No. G.19020/108/01-CCA(P)/270 dated 09-10-2023, Principal Accountant General, Mizoram in their endorsed letter No. 33/TMC/Pension/2022-23/132-133 dated 23-08-2022 and letter No. 33/TMC/Pension/2023-24/155 dated 06-12-2023, it is requested to make necessary arrangement for payment of dearness relief @ 32% and 36% on the basic pension/family pension of all eligible Mizoram Government pensioners/family pensioners with effect from 01-04-2023 and 01-09-2023 respectively after proper adjustment.
