OFFICE ORDER

The promotion of Shri Bar is further subject to the condition that no disciplinary/vigilance case is pending against him. In case any disciplinary/vigilance case of the type referred to in DOP&T OM dated 14.09.1992 is pending against the official or some punishment like stoppage of increment is in currency, he should not be relieved on promotion and the matter should be reported immediately.
