The Government of West Bengal, Judicial Department under their letter No. I/495662/2024-J/JD/V/2A-14/17 dated 14/03/2024 has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been **enhanced from 46% to** 

50% with effect from 01/01/2024.

Co-ordn./65

Vol. V/94 dated 27/09/2023, after proper adjustments of payment already made.

Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the

next higher rupee.
