Subject: Grant of dearness relief (TI) to the Odisha Government pensioners/family pensioners with effect from 01-01-2024.

In continuation to this office circular No. Pen. Co-ordn./Odisha/Vol.- VIII/DR/138 dated 06-12-2023, this is to state that the Government of Odisha in their OM No. FIN-CS3-PEN-0002-2020/6633/F dated 14-03-2024 have sanctioned dearness relief (TI) to their pensioners/family pensioners including pensioners/family pensioners of Non-Government Aided Educational Institutions including Primary Schools under School and Mass Education Department and Non-Government Aided Educational Institutions under Higher Education Department, at the rate and from the date as under:

Date of effect	Rate of dearness relief per month
01-01-2024	50% of basic pension/family pension

- 2. The above dearness relief (TI) shall also be admissible on additional basic pension/additional family pension available to the old pensioners/family pensioners based on their age.
- 3. Other provisions governing grant of dearness relief (TI) to pensioners such as regulation of dearness relief during employment/re-employment and regulation of dearness relief where more than one pension is drawn will remain unchanged.
- 4. Payment of dearness relief involving fraction of a rupee shall be rounded off to the next higher rupee.
- 5. Having been authorised by the Principal Accountant General (A&E), Odisha in their authority No. P.M/SS/F-28/2023-24/2310(34) dated 18-03-2024, it is requested to make necessary arrangement for payment of dearness relief @ 50% to all eligible Odisha Government pensioners/family pensioners on their basic pension/family pension with effect from 01-01-2024 after proper adjustment.
- 6. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Odisha etc."
