Applications are invited for filling up vacant posts in cadres of Assistant Accounts Officer, Accountant and Clerk in this office on deputation basis in various cadres on usual terms and conditions stipulated in DOPT OM No. 6/8/2009-Estt.(Pay-II) dated 17.06.2010 and amendments made thereof from time to time. The eligibility criteria for deputation is as under:-

Sr. No.	Name of the Post & Pay Level	Eligibility
1.	Assistant Accounts Officer, Level-08	Holding the analog post of Assistant Accounts Officer/Asstt. Audit Officer in the pay level-08 of pay matrix.
2	Accountant, Level-05	Holding the analogous post of Accountant/Auditor in the Pay level-5.
3	Clerk, Level-02	Holding the analogous post on regular basis in the parent Office.

Terms and conditions:-

1. The officials, who are in direct line of promotion shall not be eligible for appointment on deputation basis. Similarly, deputationist shall not be eligible for promotion in this office.
2. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on closing date of receipt of applications.
3. The period of deputation shall be initially for one year and can be extended further as per availability of vacancies and suitability of the candidate.

It is requested to kindly forward applications of interested officials who fulfill the above criteria with your recommendations along with bio-data (Service particulars in

enclosed proforma), attested copies of APARs for the last five years and vigilance clearance certificate to this office by 31.05.2024.
