Subject: Grant of Dearness Relief to the Haryana Government pensioners/family pensioners with effect from 01-07-2023 and 01-01-2024.

In continuation to this office circular Pen. Co-ordn./Haryana/Vol.- VII/DR/65 dated 04-08-2023, this is to state that the Government of Haryana in their OM Nos. 4/3/2016-5FR/24950(2) dated 26-10-2023 and 4/3/2016-5FR/6040(2) dated 15-03-2024 has sanctioned dearness relief on revised pension/family pension of their pensioners/family pensioners as under:

Date of effect	Rate of dearness relief per month
01-07-2023	46% of basic pension/family pension
01-01-2024	50% of basic pension/family pension

- 2. The payment on account of dearness relief involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
- 3. All other conditions for payment of dearness relief to pensioners/family pensioners on revised pension/family pension contained in FD's instructions No. 2/23/2016-1Pension dated 03-03-2017, as circulated under No. Pen. Co-ordn./Haryana/Vol.- VII/Revision/57 dated 04-07-2017, shall be applicable.
- 4. Having been authorised by the Pr. Accountant General (A&E), Haryana in their letter No. Pen-1/Gen-26/DA/2022-23/04-76 dated 04-04-2024, it is requested to make necessary arrangement for payment of dearness relief to all eligible Haryana Government pensioners/family pensioners @ 46% and 50% on their basic pension/family pension with effect from 01-07-2023 and 01-01-2024 respectively after proper adjustment.
- 5. The charges on this accounts are debitable to the head "8793-I.S.S.A/cs.; Government of Haryana etc."
