Date of effect Rate of dearness relief per month
01-01-2024 50% of basic pension/family pension

2. Payment of dearness relief involving fraction of a rupee shall be rounded off to the next higher rupee.

Having been authorised by the Director of Audit & Pension, Government of Arunachal Pradesh in their letter No. DAP/PEN-II/99-2000/VOL-I/02-03 dated 25-04-2024, it is requested to make necessary arrangement for payment of dearness relief @ 50% on basic pension/family pension to all eligible Arunachal Pradesh Government pensioners/family pensioners with effect from 01-01-2024 after proper adjustment.
