Subject : **Non-Payment of Government Pension through AXIS Bank**

In continuation to Pension Group office order No. Pen. Co-ordn./57 Vol.II(B)/86 dated 13/09/2023, it is to communicate to all concerned that AXIS Bank vide their letter No. AXISB/KMB/OPERATIONS/2024-25/0306 dated 22/04/2024 (copy enclosed) have conveyed their inability to disburse WB State Government pension as they are not yet live with the disbursement mechanism for the same.

Accordingly, all Pension Reporting sections and Pension-VI section are intimated not to issue any PPO in favour of AXIS Bank. Further development, if any, would be communicated accordingly.

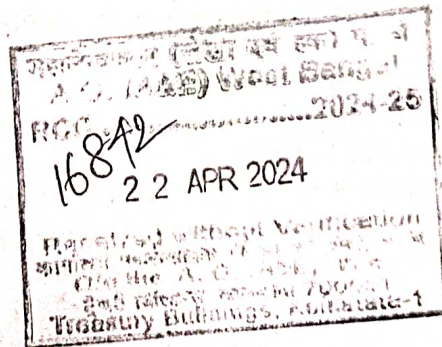
