Classification of divisions has been made on the basis of new guidelines in respect of Transfers and postings of Divisional Accounts Officers/Divisional Accountants issued by Headquarters office vide letter dated 20/03/2015 & 05/01/2022. Thus Sr.DAO are entitled for Very Heavy divisions, DAO-I are entitled for Heavy divisions, DAO-II for Medium divisions and Divisional Accountants for Light divisions. Your preference of station may be made strictly according to your entitlement of divisions.
