The undersigned is directed to refer to this Ministry OM No. 4(1)-18/63-H dated 03.03.1987 and No. H.11020/2/2023-EHS dated 26.07.2023, vide which Central Government employee having valid CGHS card has the option to avail medical benefits under CGHS either for their parents or parents-in-law.

- 2. This section have been receiving queries through telephone, email, RTI and Public Grievance etc. regarding availability of the said options to the CS(MA) beneficiaries as well, at par with CGHS beneficiaries.
- 3. The matter has been examined in this Ministry and it has been decided to extend the similar option to beneficiaries under CS(MA) Rules, 1944, also to enable them choose among either parents or parents-in-law for availing medical facilities.
