**C I R C U L A R**

Fresh or existing candidates who are eligible and intending to apply for SAS/IE/CPD-I, II & III Exam-1 of 2024, may submit their application in Admn-I section on or before 11-06-2024. The cut-off date for eligibility for the examinations is **01-03-2024**. The date sheet of the examination would be intimated in due course.

Eligibility criteria for the examinations are as follows:

1. For SAS examination, all confirmed Group C officials and Non-gazetted Group B officials with 3 years of continuous service in one or more post(s) in a particular field office who have cleared SAS prelims examination is eligible to appear for the SAS examination.
2. For CPD examination
  - (a) All Sr. AOs are eligible to take the CPD-I examination. AAOs are eligible to appear for the CPD-I examination after completion of four years of continuous service in the grade.
  - (b) The CPD-II examination can be taken by the Sr. AO/AAO after elapse of four years from qualifying their CPD-I examination.
  - (c) The CPD-III examination can be taken by the Sr. AO/AAO after elapse of three years from qualifying their CPD-II examination.

The candidates who are on deputation to other offices within the department must submit their applications directly to this office under intimation to Administration of the borrowing offices. Such candidates must make all exam related communications to this office directly for timely completion of registration process/other examination related issues.
